

### **Total Security Management Concept**

- a) The organization is positioned for the realities of the global trade environment.
- b) The total value chain is highly visible.

## **Tactical Tools of TSM**

- The 4 Value Chain V's
  - Visibility: what do you have in the supply chain, where is it, when does it depart/arrive
  - Variability: control of those things you don't want to vary, and those you do
  - Velocity: products in motion tend to be safer
  - Vulnerability: reduction by minimal exposure, good controls, sound procedures (both ours and our 3PLs)

### **Tactical Tools of TSM**

- The 4 Security D's:
  - Deter: prevent a discontinuous event from ever happening
  - Detect: early warning and response plans are critical, awareness and communication
  - Delay: delaying the event until help arrives, be it thefts in progress or shipments into bad weather.
  - Dispatch: have a response planned in the event of an incident; a quick response can prevent or recover material quickly.

### **Tactical Tools of TSM**

- The 4 Solution Set C's:
  - Coordination: alignment of mutual business goals and imperatives
  - Cooperation: builds the essential element of trust among all the value chain partners
  - Consultation: provides the opportunity to resolve minor issues before become major vulnerabilities
  - Collaboration: the implementation of mutually beneficial solutions

## Planning for Risk Prevention

- Security Plan
  - Standards of Care
    - Realistic
    - Effective
    - Enforceable
- Business Continuity
  - Planning
  - Resource Management



**Phase I - Requirements & Design:** Fact finding and analysis. "Business Impact Analysis and Risk Assessment". Determine recovery strategies, costs, and secure management approval/funding.

Phase II - Plan Development: With the selected strategy, develop and document recovery plans, order and install any hardware necessary to support the strategy. Build scenario based recovery plans and arrange for any associated recovery support services.

**Phase III - Testing:** Development and execution of test plans/exercises to verify the recovery plan(s). Report issues and action items arising from tests and perform mitigation activities. Acceptance and signoff of the plans. Plan to test annually.

Phase IV – *Implementation:* Establishment of an on-going Change Controlled Maintenance mode. DR/BC links to Change Control System.
